The above deposit is to guarantee any and all indebtedness for water and/or wastewater service which may be or may become due to Southlake Utilities, Inc. ("Company") by this Applicant. Applicant agrees that this deposit, or any portion thereof, may be applied in discharge of any indebtedness of Applicant to Company.

Upon discontinuance of service covered by this deposit and the presentation of this receipt and proper identification, Company agrees to refund to Applicant the deposit, less any amounts due to Company.

Applicant agrees that Company, its agents or employees shall at all times have access to Company's meters and the area will be kept free of interference from obstructions, shrubbery, trees, fences and pets. Applicant agrees that it shall hold Company, its agents and employees harmless and Company shall not be liable for any damage or injury alleged to have occurred through Company, its agents or employees conducting meter readings, repairs or inspection of Company's facilities, whether such damage shall have occurred through negligence or otherwise, and whether such damage or injury shall occur to real property, persons or pets.

Applicant agrees that bills for water and/or wastewater service will be paid within twenty one (21) days of mailing bills. After five (5) days, Company shall have the right to disconnect service and charge a fee for reconnecting service(s). The use of any debit or credit card, will result in either a \$2.85 or 3% (whichever is greater) additional fee.
